Banyan Tree Holdings Limited (the "Company") announced on 14 May 2020 that it is undertaking a renounceable and non-underwritten rights issue (the "Rights Issue") of S\$50,402,608 in aggregate principal amount of 7.5 per cent. convertible bonds (the "Convertible Bonds") convertible into new ordinary shares in the capital of the Company (the "Shares"), on the basis of 6 Convertible Bonds for every 100 existing Shares held by entitled shareholders as at the record date, fractional entitlements to be disregarded. As disclosed in the same announcement, Mr. Ho KwonPing ("Mr. Ho") has provided an irrevocable undertaking (the "Irrevocable Undertaking") to, inter alia, procure the acceptance of and payment in full for the entire pro rata provisional allotment of Convertible Bonds based on 358,948,882 Shares up to a maximum total subscription of S\$25,201,304 in aggregate principal amount of Convertible Bonds.

Pursuant to the Irrevocable Undertaking, the following parties have renounced their nil-paid rights to subscribe for Convertible Bonds ("Nil-Paid Rights") in favour of HSBC (Singapore) Nominees Pte Ltd ("HSBC Nom"), acting as nominee for RHYC Pte. Ltd. ("RHYC"), a company jointly owned by Mr. Ho and Ms. Chiang See Ngoh ("Ms. Chiang"):

(a) HSBC Nom and Raffles Nominees (Pte.) Limited ("Raffles Nom"), acting as nominees for Bibace Investments Ltd, have renounced 17,191,192 Nil-Paid Rights in favour of HSBC Nom, acting as nominee for RHYC;


(b) Raffles Nom, acting as nominee for KAP Holdings Ltd., has renounced 42,000 Nil-Paid Rights in favour of HSBC Nom, acting as nominee for RHYC; and

(c) Raffles Nom, acting as nominee for Li-Ho Holdings (Private) Limited, has renounced 517,740 Nil-Paid Rights in favour of HSBC Nom, acting as nominee for RHYC.

Following such renunciation and by virtue of the Securities and Futures Act (Chapter 289 of Singapore), Mr. Ho is treated as having an interest in an aggregate of 18,116,932 Nil-Paid Rights, comprising:

(i) 360,000 Nil-Paid Rights provisionally allotted to Recourse Investments Ltd. ("Recourse") (a company jointly owned by Mr. Ho and Ms. Chiang); and

(ii) 6,000 Nil-Paid Rights provisionally allotted to, and 17,750,932 Nil-Paid Rights renounced in favour of, HSBC Nom, acting as nominee for RHYC.
